In March we have informed you that METRANS is starting a new project, the service to and from **Terminal ZILINA**. After the first days of the operation has been started, we would like to share with you the feedback and give you a picture how it works.

The first train, a **METRANS train**, arrived to the TIP Zilina terminal. We as METRANS are using our most modern Bombardier Traxx E- locomotive to connect the terminal. The advantage of the terminal TIP Zilina is that we can arrive directly to the terminal without additional shunting costs.



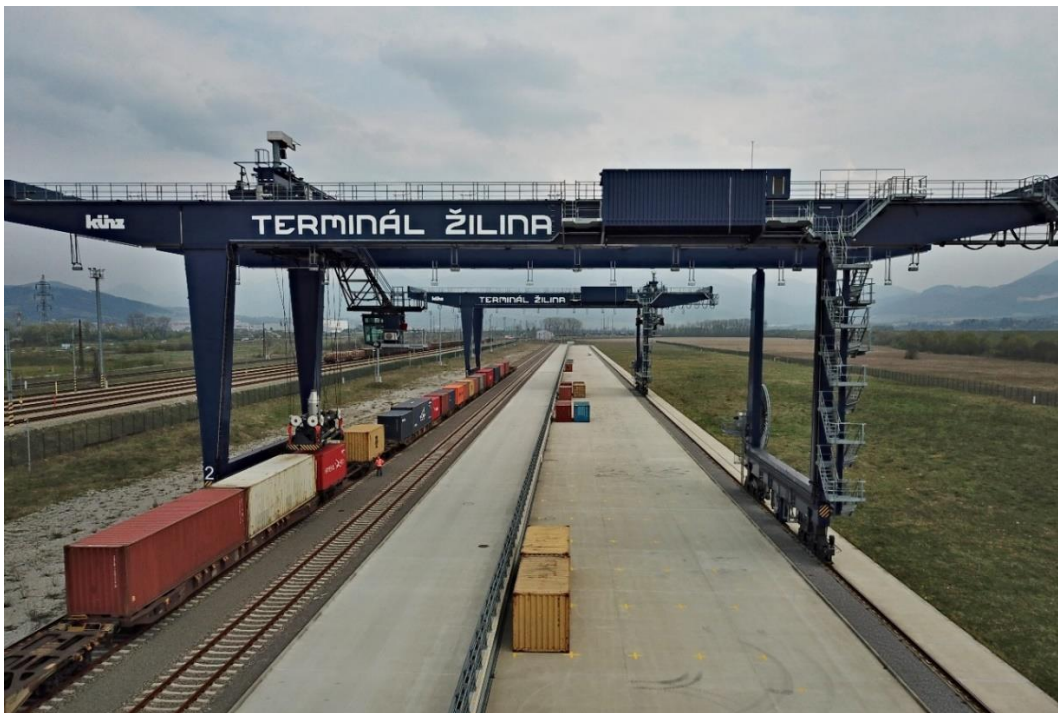
The **METRANS HUB concept**, where TIP Zilina is connected to the DUNAJSKA STREDA HUB TERMINALS allows us to connect this new service to our services HAMBURG, BREMERHAVEN, KOPER, DUISBURG, but allows also a costs effective equipment moving, however the ZILINA REGION is having a well-balanced cargo flow.
